5 **ORDINANCE NO. 3973**

6 An ordinance amending the Code of Ordinances of the City of Slidell, Chapter
7 19, Parks and Recreation, Section 19-9. Rules and regulations for all city parks.
8

9 WHEREAS, Chapter 19, Section 19-9(g) of the Code of Ordinances of the City
10 of Slidell, related to City of Slidell park hours, currently reads:
11

12 (g) Park hours shall be 6:00 a.m. to 10:00 p.m. Sunday through
13 Thursday and 6:00 a.m. to 12:00 a.m. Friday and Saturday; and
14

15 WHEREAS, the City of Slidell provides for park hours for certain of its larger
16 parks elsewhere in its Code of Ordinances, specifically in Chapter 10, Section 10-33(n);
17 and
18

19 WHEREAS, the City of Slidell desires to assist in maintaining the integrity and
20 tranquility of neighborhoods surrounding, or in proximity to, smaller City of Slidell parks by
21 amending Chapter 19, Section 19-9(g) of its Code of Ordinances to change and clarify the
22 operational hours of parks within the City of Slidell not mentioned in Chapter 10, Section
23 10-33(n) of its Code of Ordinances; and

25 WHEREAS, the City of Slidell desires to amend Chapter 19, Section 19-9(g) of
26 the Code of Ordinances, City of Slidell, Louisiana as follows:


28 (g) Except as otherwise provided in Chapter 10, Section 10-33(n) of the

30 therein, park hours shall be 7:00 a.m. to 9:00 p.m. each day of the week.

12 identified therein, park hours shall be 7:00 a.m. to 9:00 p.m. each day
